14.09 CONFIRMATION OF MINUTES OF PREVIOUS MEETINGS

The Chairman reported an amendment to the minutes at 5.09. Cllr Mudge seconded not proposed the Freedom of Information Act to be adopted. Subject to this amendment Cllr Power proposed and Cllr Mudge seconded the minutes of the meeting of the 12th January 2009.

15.09 DECLARATIONS OF INTEREST

The Chairman reminded the Cllrs present of the need to declare any personal or prejudicial interests in respect of any items included on the Agenda.

16.09 MATTERS ARISING

Correspondence has been received from WDBC re Martins Park Whiddon Down. The Cllrs requested that the Clerk acknowledge this letter with thanks and ask for the date of the appeal so that appropriate representation can be made, which would be based upon previous comments made.

Cllr Hester has undertaken some research in connection with the possible closure of Turnpike Road. He requested that the Clerk write to WDBC for any survey results in connection with the recently established roundabout at the top of Whiddon Down. Any traffic surveys undertaken after the installation of the roundabout together with copies of the plans and proposals for the bypass road towards North Tawton should also be requested. Also plans and proposals in connection with the 2 stone bus shelters, footpath from the Village Hall to the Services and for the mini roundabout. Copies of the original traffic order to include Turnpike Road to be requested together with details of any traffic orders carried out on Turnpike Road.

17.09 INSPECTOR PETER TURNER

Cllr Savage introduced Inspector Peter Turner who had attended the meeting in place of Superintendent Sharpe. The Chairman expressed his disappointment that Superintendent Sharpe had not attended the meeting, as he felt that it was a policy issue to be addressed. Inspector Turner apologised for her absence and confirmed that he would pass the comments back to Superintendent Sharpe. However, Superintendent Sharpe had deemed it to be a sector issue and Inspector Turner would endeavour to address as many of the issues as possible.

Various speeding issues around the Parish were discussed especially with motorcycles. Traffic has been tasked to look at the problem areas and Inspector Turner has requested monthly updates on the position. It is being treated as a 'red target' for the traffic division. The safety camera team will be monitoring the position within the next few months. Devon and Cornwall Constabulary are looking into the possibility of funding 2 flashing boards to warn motorists of the speed limits and should one of these prove to be needed in the area, it will be fitted in an appropriate place.

It was agreed WPC Wilson would maintain monthly contact with the Council and Inspector Turner would report to the Council at the June 2009 meeting with the results of the surveys etc.

The Chairman thanked Inspector Turner for attending the meeting and for the progress which was being made, albeit slow.

18.09 HIGHWAYS

Cllrs requested that the Clerk write to SW Highways requesting that the brambles and scrub are cleared from the Venton lay-by, in order to open the lay-by up to the road. It was felt that the lay by is becoming too hidden and there were concerns raised for fly-tipping and it was felt that by opening up the lay by this would alleviate any unscrupulous activities.

Complaints had been received from several parishioners about Higher Fingle Farm and the

<p>rubbish which had been seen to be blowing about the road, rats crossing the road, smells from the bins, hedges not being trimmed and the visual impact. Concerns had been raised especially as it was the intention to open an Educational Centre at the Farm and it was not felt that this was a model farm in respect of modern farm practice. Following various discussions it was felt that the Clerk should write to the tenants in the first instance to see if these issues could be resolved before taking matters further.</p>	ACTION
