Minutes for meeting of Drewsteignton Parish Council that took place on Monday the 15th of September 2025 at 7.30pm in The long room, Drewe arms, Drewsteignton.

Also present, Lou Butler(clerk) plus 6 members of the public, County Cllr Davies and Borough Cllr Gutherie.

Business Transacted

1.9.25: Welcome

Chair welcomed everyone to the meeting and reminded everyone that an audio recording would be taken from item 1 on the agenda to aid note taking and would be deleted once the draft minutes had been written.

2.9.25 Current Vacancies.

Chair reminded the council of the current vacancy in the Crockernwell ward.

3.9.25: Apologies for absence:

All in attendance.

4.9.25: Minutes of the Last Meetings. Draft Minutes were made available on the website for the previous parish council meeting dated 21st of July 2025. Cllr Macy requested an amendment for the attendees of the meeting. The clerk asked for the date of the next meeting to be corrected.

Cllr Brennan corrected the minutes then proposed they were an accurate portrayal of the last meeting and Cllr Hember seconded, all in favour. Motion carried RR25/40

5.9.25: Declarations of Interest

Cllrs were invited to declare any interests they may have in items on this agenda, including the nature of the interest. Cllrs were reminded of their responsibilities to keep their register of interests updated. Cllr Di Battista declared that he had pecuniary interest in item 8.9.25 (a) as it was his property.

6.9.25: Public Speaking Time (max. 3minutes/person. Session time: 10 minutes).

Public Speaking Time was given firstly to the residents of Crockernwell who have attended the previous meeting in July. They had been contacted that day and advised there was no further water quality update. They were enquiring if the customers had enough bottled water. Cllr Brennan shared that he had also been in contact with SWW on the 5th of September and they had found that the water supply to his property in Crockernwell had been restricted to 0.75 bar for at least the last 20 years. The engineer commented that "they are aware there is an issue" (relating to the water quality) "but we don't know how to fix it"

It was noted by all involved that the communication at SWW is hard to understand, although they claim to record calls for training purposes. There is no continuity between departments or staff members from the same department. Each time anyone calls they must explain the situation each time. Even with a case number in place.
